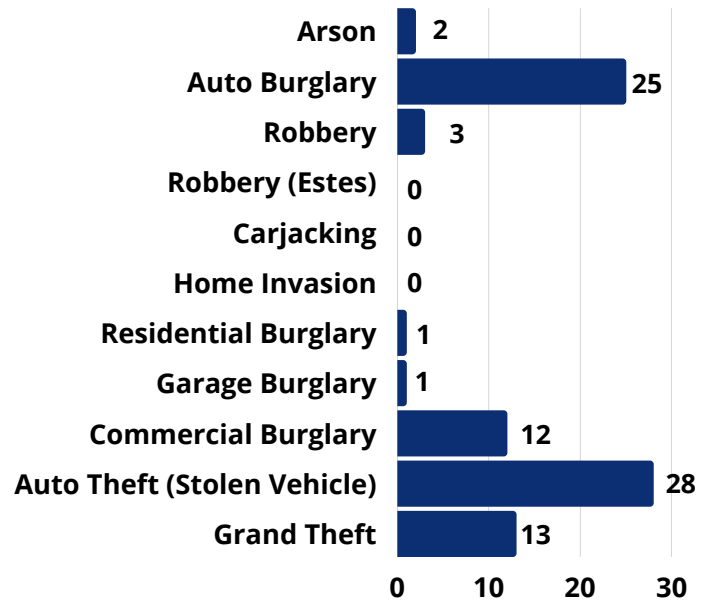




Fremont Police Week In Review

Arson

On 7/26, officers responded to a restaurant on Fremont Blvd regarding flooding inside. Officers discovered signs of forced entry and found that the fire prevention sprinkler system had caused the flooding. During the search, officers smelled a strong gas odor and noted that all kitchen stovetop burners were on. Fremont Fire Department ventilated the restaurant, and once the building was deemed safe, officers located a large portion of the business that had caught fire and was extinguished by the sprinklers before arrival. This case remains under investigation. #230726004

On 7/29, officers responded to assist Fremont Fire Department regarding a structure fire on Bradley St. The residence shed was set ablaze, which caught some of the residence and a neighbor's residence on fire. This case remains under investigation. #230729008

Attempted Homicide

On 7/31, officers responded to the reporting party (victim) near Stewart Ave, who reported that his neighbor (subject) attempted to strike him with a hatchet. Officers attempted contact with the subject, who was hiding in his RV. Ultimately, the subject, an adult out of Fremont, exited the vehicle, surrendered, and was arrested. #230731024

Domestic Violence/Drunk in Public

On 7/26, officers responded to a domestic violence report on Fremont Blvd. The caller, an adult from Fremont, claimed her boyfriend had beaten her up. Officers discovered that the person she named as her boyfriend had been deceased for several years. The subject had made similar calls before. Officers found her under the influence of alcohol outside and determined she could not care for herself. She was cleared at Washington Hospital before being taken to jail. The domestic violence report was determined to be unfounded. #230726037

Felony Domestic Violence

On 7/30, officers responded to a victim who reported that her boyfriend had battered her. Officers arrested the subject, an adult out of Fremont, and served him with an Emergency Protective Order, which included a prohibition on possessing firearms. While seizing the firearms at the subject's business on Industrial Pl, officers located several pipe bombs with the firearms. Alameda County Bomb Squad responded to detonate the devices safely. #230730007

Mental Health Evaluation Hold

On 7/27, multiple parties reported that an adult subject was walking around naked at a park on Pecos Ave and Blackstone Way. Officers accompanied the subject to his residence and found the interior had been destroyed, with a large mud pile in the middle of the room. The subject had also turned the bathtub on and flooded the entire residence. He was placed on a mental health hold. #230727011

Shots Fired

In the early morning of 7/28, officers responded to a reported shooting near Cabrillo Dr and Vincente Dr. While driving away from his residence, the victim observed a subject peering into a neighbor's vehicle, and after he turned his vehicle to get a better look, several subjects approached the victim's vehicle. One subject brandished a firearm and fired one shot. As the victim fled in his vehicle, the subjects chased him and fired a second shot. The victim's vehicle did not appear to be struck by any rounds, and the victim did not suffer any injuries. This case remains under investigation. #230728005

Suspicious Circumstance

On 7/25, dispatch received a call from a reporting party who claimed that his wife had passed away while under hospice care at their home on Terry Ter. The caller said a mortuary had already collected the deceased. Officers contacted the Alameda County Sheriff's Office, Coroner's Bureau, all local mortuaries, and several outside agencies - none of which knew about the incident. Officers responded to the address provided by the caller and learned that the residents had not placed the call and were uninvolved. Multiple database searches on the caller's telephone number revealed the number was registered to a voiceover internet company. Officers determined the call for service to be unfounded. #230725004

Warrant Service

On 7/26, officers responded to Greenwood Dr regarding a subject who set fire to a tree. Officers determined it was a campfire, and the subject had an outstanding felony warrant. The subject, an adult out of Fremont, was arrested. #230726029
