SRO Officer Kathryn Samayoa (Irvington H.S.)

SRO Officer Thania Guzman (American H.S.)

EXECUTIVE SUMMARY

A YEAR IN REVIEW 2022-2023

- The Fremont Police Department was nominated and received the National Association of School Resource Officers (NASRO) 2022 Model Agency Award. This significant achievement recognized the unit's efforts at applying the principles of being a law enforcement officer, educator, and informal mentor.
- The Chief of Police with assistance from the SRO Unit launched the Chief's Youth Advisory Board (CYAB). This board of students represent FUSD High Schools to include a private high school in Fremont. <u>https://www.fremontpolice.gov/about-us/officeof-the-chief-of-police/youth-advisory-board</u>
- During the academic year 2022-2023 the SRO Unit investigated 42 sexual/abuse cases.
- The SRO Unit focused on traffic related issues around our schools. During the academic year 2022-2023 the SRO Unit conducted 407 Traffic Saturation Missions at area schools.
- SRO's responded to 52 calls for service involving assistance in conducting a Mental Health Evaluation (WI 5150). Of the 52 calls for service 17 individuals were held on a WI 5150 for further evaluation.
- The SRO Unit responded to 1,751 calls for service.
- The SRO Unit documented 173 incidents in a police report
- The SRO Unit investigated 42 suspected abuse/sex related incidents in the 2022/2023 school year.
- The SRO Unit investigated 14 battery incidents for the 2022/2023 school year.
- 16 Notice to Appear or citations were issued
- The Fremont Police Department reinstated the Explorer Program.

TRAINING

The Fremont Police Department places an emphasis on contemporary training designed to improve the quality and efficacy of our service. SRO's received focused specialized juvenile related training beyond the training received by patrol officers.

Training Topic

Lieutenant Brian Murphy-First Responding Officer of the Sikh Temple Massacre (Wisconsin): A debrief on critical incident involving a white supremacist who opened fire on a Sikh congregation in 2012. The focus of this keynote address are elements of survival, prejudice and community. (NASRO Conference)

Advanced SRO Course: (2 Officers completed) A 24 hour block of direct instruction that focused on more advanced techniques for the SRO. Topics include law updates, technology/social media, improving communication with administrators and information on current youth-related topics. Participants will also spend two hours at a school building for a site assessment." (NASRO Conference)

Sheriff Tony Spurlock- STEM School Highlands Ranch School Shooting (Colorado): A debrief on an active shooter incident at a charter school in 2019. The focus of this keynote address echoes the necessity for vigilance but for SROs to remember they are not only the trusted entity to student, but to school and parents. (NASRO Conference)

Shifting from Trauma Informed to Trauma Responsive: Officer Deb VanVelzen and Supervising Case Manager Jenn Stalder provided an overview of the developing brain and impacts of trauma in Adverse Childhood Experiences (ACE). Presentation included research-based strategies in the areas of de-escalation, active listening and restorative practices. **(NASRO Conference)**

The State of School Safety in 2022: Sandy Hook parent Michele Gay presented results from this year's National State of School Safety Survey conducted by Safe and Sound Schools. Presentation included the unpacking of national datasets, issue breakdowns and challenges/opportunities to build a safe and sound school. **(NASRO Conference)**

Wisconsin Critical Incident Response Teams: Coordinator Kelly DeJonge & Wisconsin DOJ Office of School Safety Director Trish Kilpin provided an overview of the regionally based Critical Incident Response (CIR) teams that are being developed in Wisconsin. CIR teams provide support, resources and assistance to all K-12 schools in Wisconsin that have been faced with a critical incident. **(NASRO Conference)**

Youth Violence Interventions & the OJJDP Comprehensive Gang Model: A panel discussion involving subject matter experts highlighting leading-edge strategies and federal resources to support prevention and early intervention efforts, locally and nationally. The Office of Juvenile Justice and Delinquency Prevention's National Gang Center discussed the comprehensive Gang Model, a community-based approach; bringing the community, law enforcement, and partner agencies together to help communities overcome persistent and serious problems with youth gangs. (NASRO Conference)

Chief John Newman- Debrief of the Parkland Shooting and the Legislative Mandates: 4 Years Later: Keynote address included what happened at Marjory Stoneman Douglas High School and how Florida school districts had to manage the legislative mandates that came out of that tragedy. **(NASRO Conference)**

Building Resilience Around Suicide Prevention: Detective/SRO Stacey Collis and Psychologist Lisa Langerman presented conversations covering teen suicide, thoughts of suicide and other related mental health issues during unprecedented pandemic time. Resources, responses, resiliency, relationships, and reflection were topics touched. **(NASRO Conference)**

ARRESTS

The term arrest is often synonymous with an individual being placed in handcuffs and transported to jail. This is referred to as a physical arrest. In lieu of jail, an arrest could also be adjudicated through a citation or a Notice to Appear (NTA). This is essentially an alleged offender's promise to appear if summoned by the court.

California Penal Code 834 defines an arrest as "taking a person into custody, in a case and in the manner authorized by law." Arrest authority within the jurisdiction of the Fremont Police Department is authorized through California Penal Code 830.1 and 636, respectively:

a. When the officer has probable cause to believe the person committed a felony, whether or not committed in the presence of the officer.

b. When the officer has probable cause to believe the person has committed a misdemeanor in this jurisdiction and in the presence of the officer.

c. When the officer has probable cause to believe the person has committed a public offense outside this jurisdiction, in the presence of the officer and the officer reasonably believes there is an immediate danger to person or property, or of escape.

d. When the officer has probable cause to believe the person has committed a misdemeanor for which an arrest is authorized or required by statute even though the offense has not been committed in the presence of the officer such as certain domestic violence offenses.

e. In compliance with an arrest warrant (Lexipol, 2022.)

YOUTHFUL OFFENDERS

The Fremont Police Department is committed to releasing youthful offenders from temporary custody as soon as reasonably practicable and keeping them safe while they are in temporary custody at the Fremont Police Department. Youthful offenders should be held in temporary custody only for as long as reasonably necessary for processing, transfer, or release (Lexipol, 2022).

When a youthful offender commits a statutory offense, Schools Resource Officers have several options:

1.Admonishment- A verbal reprimand of the student and a call to a parent/guardian.

2.Issuance of a Notice to Appear (NTA)- The issuance of an NTA is a promise that the juvenile and their respective parent/guardian will appear if asked by the Alameda County Probation Department. Further, it is a promise that the parent will provide supervision of the youthful offender. Through the issuance of an NTA, the officer is also asking probation to consider pursuing charges formally. With a completed NTA in hand, the SRO still has discretion to forward the matter to Diversion through Fremont's Youth and Family Services. If the juvenile meets the criteria for diversion services AND successfully completes the program, the NTA becomes void, preventing the juvenile from further progress in the justice system.

3.Custody- A physical arrest of a juvenile offender. Upon arrest, the officer may still issue an NTA and release the youth to the care/custody of a parent/guardian. For serious, violent offenses, the officer may transport the youth to the Alameda County Juvenile Justice Center (San Leandro) for booking.

SCHOOL YEAR 2022-2023 DATA POINTS

16 Notice to Appear/Citations Issued: 12 of 16 cases referred to **Diversion in lieu of introduction to the juvenile justice system**.

Data Points

The victim reported Online Harassment and the suspect was identified after a search warrant was issued for social media account information. **Referred to Diversion.**

The juvenile brandished a knife on school campus PC 417. Referred to Diversion

The juvenile was caught stealing from a store and when confronted assaulted the store owner. The victim desired prosecution and the case was forwarded to the Juvenile Probation Department for charging.

Juvenile was involved in a fight. **Referred to Diversion**

Juvenile was issued a Notice to Appear for PC 422(A) Criminal Threats. Referred to Diversion

Juvenile was issued a Notice to Appear for PC 242 Battery. Referred to Diversion

Juvenile was issued a Notice to Appear for PC 422(A) Criminal Threats. Referred to Diversion

Juvenile was issued a Notice to Appear for PC 243.4 Sexual Battery. **Referred to Diversion.**

Juvenile was issued a Notice to Appear for multiple charges to include making a bomb threat. The case was sent to the Juvenile Probation Department for charging. The case was charged.

Juvenile was issued a Notice to Appear for PC 242 Battery. Referred to Diversion

Juvenile was involved in another fight and the case was sent to Juvenile Probation for review.

Juvenile was issued a Notice to Appear for PC 148(A)(1). Referred to Diversion

Juvenile was issued a Notice to Appear for PC594(A)(2) Vandalism. Referred to Diversion

Juvenile was Issued a Notice to Appear for PC 635.2(a) Online Harassment. Referred to Diversion

Three males "jumped" a student (victim) as the victim walked home from school. The SRO unit investigated the incident and determined one of the suspects involved in the battery was a student at another school. Follow up was conducted and the suspect was contacted at school and a search of his vehicle that was parked on campus was conducted. Inside the vehicle a firearm and drugs packaged for sales were located. The suspect was arrested, and the case was sent to the Juvenile Probation Department.

Juvenile was issued a Notice to Appear for PC 242 Battery. **Referred to Diversion.**


The SRO Unit staffed 99 special events (Dances/Athletic Events/Graduations)


Juvenile Offender Arrestees By Ethnicity:











REPORTS (ARS) COMPARISON – BATTERY SCHOOL YEAR '21/'22 – '22/'23




