Battery

On 3/10, a subject attacked a victim outside of a liquor store on Stevenson Blvd. The subject had entered the store claiming that the clerk had found his phone outside, but he was upset when the clerk asked him to prove it was his phone. The subject exited the store, approached the victim sitting in his vehicle, and attempted to take the victim's phone from the dashboard. An altercation followed, in which the subject punched the victim and rode away on a bicycle. This case remains under investigation. #240310002

Brandishing a Weapon

On 3/7, officers responded to a security guard who was patrolling a parking lot on Warm Springs Blvd. A subject brandished a long metal pole at the guard and fled before officers arrived. Officers conducted an area search but did not locate the subject. #240307006

Child Abuse

On 3/6, officers responded to an afterschool program on the 45000 block of Grimmer Blvd for a welfare check of three juveniles. The three juveniles shared accounts of physical abuse by their parents. The parents arrived at the school with the juveniles' younger sibling, and both parents acknowledged that discipline occurred at their residence. Because of signs of physical abuse, all four juveniles were placed into the custody of Child Protective Services and transported for medical attention. #240306019

Commercial Burglary

On 3/11, six subjects used a stolen vehicle to smash into the front of a smoke shop on Fremont Blvd and forced entry. The vehicle had been stolen just before the burglary, and three of the subjects were captured on surveillance footage holding firearms. Due to the debris caused by the collision, the subjects could not gain full entry to the shop, and no items appeared to have been stolen. This case remains under investigation. #240311006

Domestic Violence

On 3/6, a victim reported being beaten by his wife (subject). He said the subject threatened him with scissors, cut his clothes, and bit him. Officers observed bite marks on the victim's arm. The subject was arrested. #240306002

Mental Health Hold

On 3/10, officers responded to an apartment on Thornton Ave regarding a subject who was attempting to harm herself. When contacted, the subject became aggressive and avoided officers. Later, the same subject was destroying items in the apartment. After a brief struggle, officers detained her and placed her on a mental health hold. #240310026 and #240310029

On 3/10, officers responded to a report of a subject at an apartment complex on Walnut Ave. The reporting party said the subject was running around the complex and had thrown their phones and keys into a body of water. He also expressed a desire to harm himself. He was uncooperative with officers and tried to enter a patrol vehicle unlawfully. After a brief struggle, he was detained and placed on a mental health hold. #240310007

Sexual Battery

On 3/7, a victim reported a sexual battery incident while shopping at a grocery store on the 41000 block of Fremont Blvd. The subject walked past the victim, pressed himself against her from behind, and groped her. He did not speak to the victim and quickly left the market. This case remains under investigation. #240307022

Shots Fired

On 3/10, officers investigated a report of two gunshots heard near a residence on Ridgewood Dr. Officers determined that a subject inside a vehicle may have fired two rounds in an unknown direction while passing by the house. No victims or casings were located in the area. #240310003

Stolen Vehicle

On 3/8, an employee at a car dealership on Auto Mall Pkwy reported that a subject had taken a vehicle without permission. The subject had taken the vehicle for a test drive and never returned. The employee found the vehicle at a residence on Walnut Ave and used a spare key to return the vehicle to the dealership. When officers responded to the residence to request that the subject return the key fob, he did not answer the door. The employee retrieved the key fob from a family member of the subject. #240308028
