

Arson

On 9/24, officers assisted the Fremont Fire Department in responding to a brush fire near Blacow Rd and Thornton Ave. Officers found a subject near the scene who admitted to starting the fire while attempting to clean up the area. The fire was quickly extinguished, and no property damage was reported. #240924021

Attempted Robbery

On 9/28, officers responded to a clothing store on Bay St regarding an attempted robbery. The subject had attempted to snatch the victim's purse from her. The victim defended herself from the subject and locked herself inside the clothing store. The subject attempted to force the door open, then fled on foot. Another caller had also reported that the subject was climbing on vehicles in the area and flashing her breasts at those nearby. Officers responded and, after a short foot pursuit, arrested the subject. #240928015 and #P24115593

Grand Theft

On 9/30, a victim was approached on Roberts Ave by a subject who engaged the victim in conversation and removed her necklace. The same day, another victim on Macbeth Ct was approached by a subject who placed costume jewelry on the victim and removed his jewelry. In another incident on the same day, a victim was walking near Hilo St and Blacow Rd when two subjects approached her and hugged her as they removed her necklace. Petty Theft

On 9/24, officers responded to multiple calls from a convenience store on Mowry Ave. A subject stole food and began eating it outside. The same subject returned inside and began breaking items inside the store. The subject fled on a bicycle, but officers apprehended and cited him. #240924029

Residential Burglary

On 9/27, a victim reported that her vehicle had been broken into at her residence on Vivian Pl. The subjects had broken the vehicle window and used the garage door opener in her vehicle to open the garage. No loss was reported from the vehicle or residence. #240927003

Suspicious Circumstance

On 9/28, officers responded to an apartment complex on Beacon Ave regarding a reporting party who said he was being held against his will inside one of the units. The caller said he had entered the residence believing a house party was inside. Once inside, he was met by two subjects, one of whom had a gun in a holster. Officers responded to the unit and contacted the occupants, but did not find any sign of the reporting party or anyone in danger. #240928001

Unattended Death

On 9/26, a reporting party was walking her dog when she discovered a subject lying face down on the front lawn of a church on I St. Fremont Fire Department pronounced the subject deceased at the scene. Investigation revealed the subject had ingested a large quantity of unknown pills before lying down on the church lawn. The Alameda County Sheriff's Office Coroner's Bureau responded and took custody of the deceased. #240926007

Warrant Service

On 9/26, officers responded to a hospital on Mowry Ave regarding a subject who had been discharged but refused to leave. The subject also called 911 several times requesting police services. Officers contacted him and discovered two outstanding warrants for the subject. The subject was arrested. #240926036
