Incident: Officer Involved Shooting – February 9, 2021 (Update #3)

Location: 7200 Block of Stevenson Blvd.

Date/Time of Incident: February 9, 2021 at 4:44 p.m.

On Tuesday, February 9, 2021, two Fremont patrol officers were involved in an officer involved shooting in the 7200 block of Stevenson Blvd. Initial details of the incident from February 9th, including a video narrative, can be located on the Fremont Police Department's Transparency Portal, https://fremontpolice.gov/OIS.

This incident update (#3) is to release the names of the involved Fremont Police officers and suspects, to include some of the initial charges filed by the Alameda County District Attorney on February 11, 2021.

The Fremont Police Department is currently developing an in-depth detailed release of information to include video and evidence of the incident and related crimes. This information is anticipated to be available and released in the next 7-10 days. All details will be shared through our social media platforms, Nixle, Next Door and also posted to our Transparency Portal.

Fremont Police Officers:

Officer Andrew Dennis, 5 ½ years of service with the Fremont Police Department, assigned to patrol.

Officer Jeffrey Carter, 5 ½ years of service with the Fremont Police Department, assigned to patrol.

Suspects:

Juvenile #1 - 17-year-old male, resident of Hayward; Charged in juvenile court with home invasion robbery and personal use of a firearm during the commission of a felony (assault weapon)

Juvenile #2 - 16-year-old male, resident of East Palo Alto; Charged in juvenile court with home invasion robbery and personal use of a firearm during the commission of a felony (handgun)

Juvenile #3 - 15-year-old male, resident of East Palo Alto; Charged in juvenile court with home invasion robbery and personal use of a firearm during the commission of a felony (assault weapon)

Juvenile #4 - 14-year-old male, resident of East Palo Alto: Charged in juvenile court with home invasion robbery and felony evading

Juvenile #5 - 16-year-old female, resident of Hayward; arrested on 2/10/20; Charged in juvenile court with home invasion robbery and possession of stolen property

This remains an open and ongoing investigation. Additional cases and charges will be presented for charging to the District Attorney when applicable. Our next release of information will help to shed light on the totality of this case and charges.
