


# Fremont Police Week In Review

## **Auto Burglary**

On 6/6 at approximately 7:25 a.m. an auto burglary occurred in the area of Paseo Padre Pkwy and Patterson Ranch Rd. Suspect(s) shattered the victim's vehicle window and took a laptop. The victim was able to track the laptop's location to a residence in Hayward. Hayward PD was able to recover the laptop and identified two possible suspects. #220606021

## **Auto Theft**
