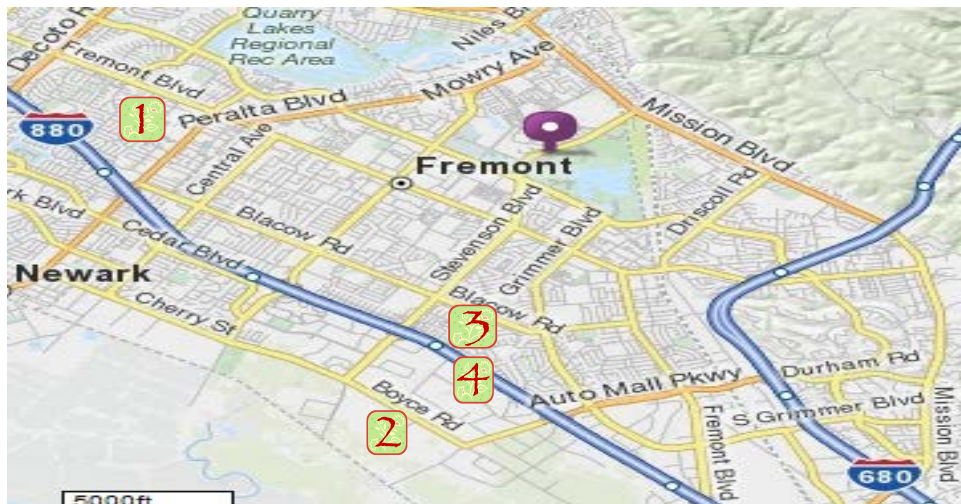

## **VEHICLE RELEASE PROCEDURES**

Vehicles can only be released to the registered owner. If it is necessary for some other person to pick up the release and/or vehicle, the registered owner must complete this form; or supply their own letter that includes all of the same information.

With this letter, the authorized person may pick up the vehicle release form from the Fremont Police Department providing he/she has a valid driver's license; the vehicle is currently registered with the Department of Motor Vehicles and pays the Police Departments vehicle release fee. Towing and storage fees are separate and are paid directly to the tow company. The vehicle may then be picked up by the authorized person from the appropriate tow yard.
